This will also help us ensure that appropriate staff is assigned to the review process. This form is required for *every* wireless facility that you propose.

Please note that this application, and approval of this application does not eliminate the need to obtain a franchise or other form of written consent from the City to use the rights of way within the City, and it is not a substitute for building, excavation or other permits that may be required.
